

Expose.sh Privacy Policy

This Privacy Policy describes how your personal information is collected, used, and shared when you use the <https://expose.sh> website and tools or services available through it (these will be referred to as the “Site” from here on).

PERSONAL INFORMATION WE COLLECT

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site and information about how you interact with the Site. We refer to this automatically-collected information as “Device Information.”

We collect Device Information using the following technologies:

- “Cookies” are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit <https://cookiesandyou.com>.
- “Local database” the Expose.sh client creates a local database on your computer and it may place Device Information inside this database including a unique client id.
- “Log files” track actions occurring on the Site and collect data including your IP address, browser type, Internet service provider, referring/exit pages and date/time stamps.
- “Web beacons,” “tags,” and “pixels” are electronic files used to record information about how you browse the Site.

Additionally when you make sign up to the Site, we collect certain information from you, including your desired email address, first and last names and other information. We refer to this information as “Signup Information.”

When we talk about “Personal Information” in this Privacy Policy, we are talking about Device Information, Order Information and Signup Information.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Signup Information that we collect generally to provide you with services offered by The Site.

Additionally, we use this Signup Information to communicate with you and provide you with information or advertising.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address and generated client id), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site and to assess the success of our marketing and advertising campaigns).

SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above. We use Google Analytics to help us understand how our customers use the Site--you can read more about how Google uses your Personal Information here: <https://www.google.com/intl/en/policies/privacy/>. You can also opt-out of Google Analytics here: <https://tools.google.com/dlpage/gaoptout>. Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information

we receive, or to otherwise protect our rights.

BEHAVIOURAL ADVERTISING

Both we and our advertising partners use your Personal Information and Device Information to provide you with targeted advertisements or marketing communications we believe may be of interest to you. DO NOT TRACK

Please note that we do not alter our Site's data collection and use practices when we see a Do Not Track signal from your browser.

YOUR RIGHTS

When you place an order through the Site, we will maintain your Order Information for our records unless and until you ask us to delete this information.

MINORS

The Site is not intended for individuals under the age of 18.

CHANGES

We may update this privacy policy from time to time in order to reflect, for example, changes to our practices or for other operational, legal or regulatory reasons.
